- 2. This statement, which is the responsibility of the Company's Management and has been approved by the Company's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, (Ind AS 34) "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013, as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India,. - 3. a. Further, the company is in the process of identifying the assets so acquired and ascertain their fair value and life.

b. The trading of the company is temporary restricted/ suspended in NSE and BSE due to procedural reasons as the company is acquired from NCLT The Company has applied to NSE and BSE for revocation of suspension.
